

Champion Energy/Sam Houston Race Park Suite – Text to Win - OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. **Eligibility.** The Champion Energy/Sam Houston Race Park Suite promotion (the “Sweepstakes”) is open to U.S. residents (excluding Puerto Rico), 18 years or older at the time of entry. Employees, officers, directors, contractors or agents of Sam Houston Race Park (SHRP), Champion Energy Services (“Sponsor”), and each of their respective affiliated companies, subsidiaries, advertising or promotional agencies and the immediate family members of each of the above and any persons domiciled with such employees are not eligible.

This promotion is intended for participation in the State of Texas only and shall be construed and evaluated in accordance with the laws of the State of Texas. All federal, state and local laws and regulations apply. Void outside Texas and within areas of Texas where electric competition is not available.

2. **Entry.** One (1) entry per person.

The Sweepstakes will begin at 8:00 a.m. Central Time on January 20, 2012, or when the contest is advertised in SHRP’s program ad, whichever is sooner; and all entries must be received by 4:00 p.m. Central Time on February 24, 2012.

How to Enter: There is no cost to enter. During the designated Sweepstakes Period, contestants may text SHRP to 444888 to submit their entries pursuant to these official rules (the “Official Rules”). Incomplete entries are void. To constitute a complete entry, you must provide your name and e-mail address on the submission form, along with any additional information required for this Sweepstakes.

Entries made in any fashion other than submitting the entry via text or entry form are void. All late, lost, misdirected, incomplete, undelivered, scrambled or destroyed entries are ineligible entries, regardless of the reason or party responsible. Sponsor may modify and amend these Official Rules as they appear herein or online from time to time during the Sweepstakes Period for clarification purposes without materially affecting the terms and conditions of the Sweepstakes. Sponsor is not responsible for printing or typographical errors; incorrect or inaccurate registration information; computer system or phone line errors, software/hardware malfunctions or other errors; or for failures or delays in transmissions that are human or technical in nature. By entering, all participants agree to be bound by

the terms of these Official Rules and the decisions of Sponsor, which shall be final. False or deceptive entries or acts will render the entrant ineligible. Entries become the official property of the Sponsor and will not be acknowledged or returned. Sponsor and its affiliates and related individuals will not accept correspondence or telephone inquiries regarding the status of entries or the administration of the Sweepstakes.

The Grand Prize Winner will receive access to a SHRP suite that holds up to 20 people on race day taking place March 3, 2012. Food and beverage will be supplied for the guests. This does not include alcohol. Grand Prize winner will be required to claim the prize at Sponsor’s Houston offices at an assigned time and this will include a publicity photo with a Champion Energy representative.

Odds of winning depend on the number of eligible entries received.

5. **Winner Notification and Acceptance.** The Grand Prize Winner will be notified by telephone and/or U.S. Mail no more than fifteen (15) days after the conclusion of the Sweepstakes Period. Return of prize notification as undeliverable may result in disqualification, and an alternate winner may be selected. Winners may waive their right to receive prizes. Prizes are non-assignable and nontransferable. No substitutions allowed, except that prizes and individual components of prize packages are subject to availability, and Sponsor reserves the right to substitute prizes of equal or greater value. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. If any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.
